Any person who has reason to get aggrieved by the order of dissolution of any such companies may raise objection in writing adduced by evidence before the undersigned within 30 days from the date of this publication. Any objection raised after the expiry of of the time stipulated hereof shall not be entertained and such aggrieved person may take recourse to the Rule 285 of the Companies (Court) rule, 1959 read with section 559 of the Companies Act, 1956 in case the company gets dissolved.
